B. The outstanding works listed in the snag lists enclosed with the "Provisional Acceptance Certificates" have been carried out by the Contractor.

- C. The defects listed in the snag lists enclosed with the "Provisional Acceptance Certificates" as well as defects observed and notified to the Contractor during the defects liability period have been rectified by the Contractor
- D. A final inspection was carried out by the Supervisor, Supervisor's Representative and the Contractor on 23 and 24 November 2015, and another Inspection was carried out by the Supervisor and the Contractor on 15 February 2016 all the defects repair works were found to be complete.
