The on-going Projects are Mukono-Katosi -Nyenga road 74km, the Mukono-Kayunga-Njeru road. 93km and offering consultancy services for the detailed design and construction supervision of the 3000 Units of the Lubowa Housing Project. The dynamic forward moving organization structure, characterized with a high degree of flexibility and creativity, has given SBI a leading edge when competing for major international contracts.

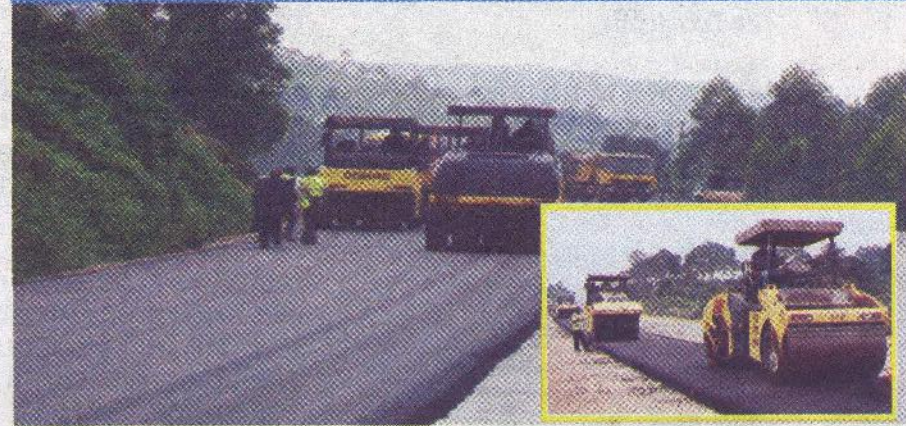

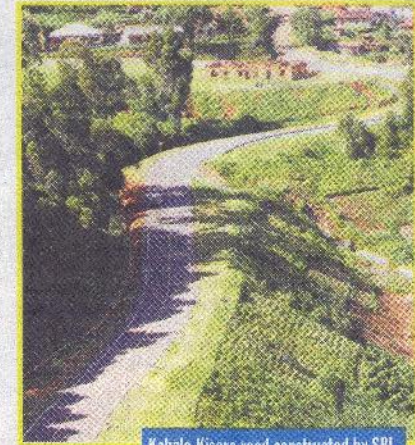
saved and people's health improve.
